C. DISCUSSION – The subcommittee will discuss the following:

- 1. Discuss Creating a Standardized Process for “Trail of the Month”** – The committee will come up with a standardized procedure and schedule for submitting monthly trails. This process will include receiving land managers’ approvals.
- 2. Discuss POS’s Role in Promoting Arizona Premier Trails System (APTS)** – The committee will discuss the development of a presentation that will aid in the promotion of the APTS and encourage applications. Members will outline a work plan and delegate responsibilities to meet their goal in presenting a draft to the full of ASCOT at the September meeting.
- 3. Discuss the Use of Various Partners for Promotion of Trail Events** – Members previously discussed utilizing various partners and agencies to

promote trail events. The group will continue this discussion and update each other on any further connections.

4. **Discuss POS's Role in Updating ASCOT's Website** – Staff will ask the committee to aid them redlining outdated content on the ASCOT webpages and brainstorm content ideas/design for the new site.
