To: Ms. Sue Black and the Arizona State Park's Rockin' River Project Manager

Regarding your presentation and recommendations that you will be presenting tonight, there is insufficient information available for comprehensive public comment by our community. In addition to any input you receive tonight we would request a 45 day public review period of all the information gathered by the State Parks and the Technical Advisory Committee. We would ask for information such as maps, studies, visitation projects, Power Point Presentations, meeting minutes, etc. be provided and housed at the Camp Verde Library for public review during this period. We would also ask that you provide a central point of contact to answer our questions to include a telephone number, an email address, and a responsible State Parks person. At the end of this 45 day period, we would ask that you reconvene this public meeting to hear our comments and alternatives (both written and oral).

Considering the amount of time (2 years) that the State Parks has worked on this without community input, we feel this is a reasonable request to allow public participation. Please acknowledge your agreement with this delay by July 21, 2017. If we receive no response by that date we will assume you are declining this request.
